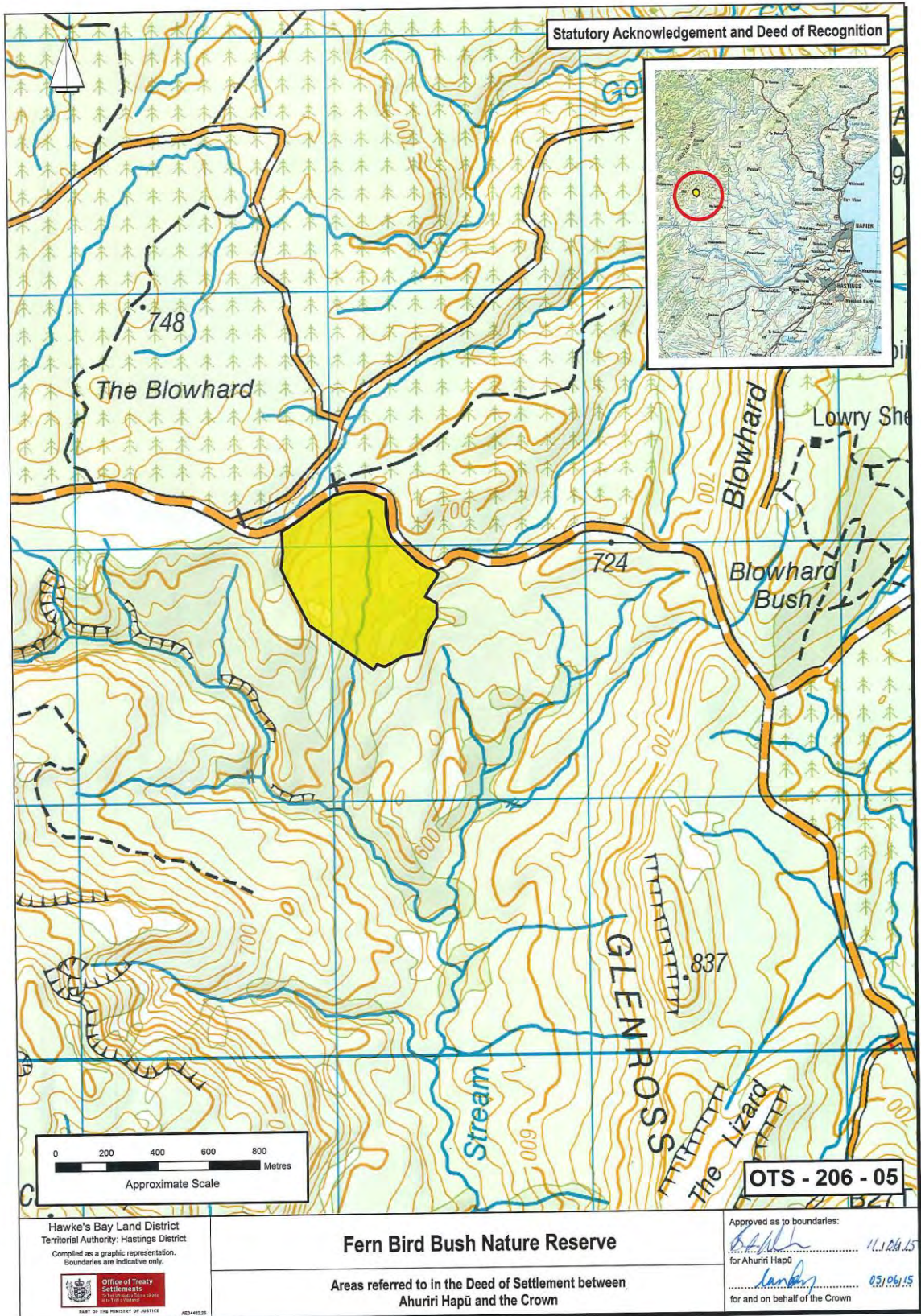

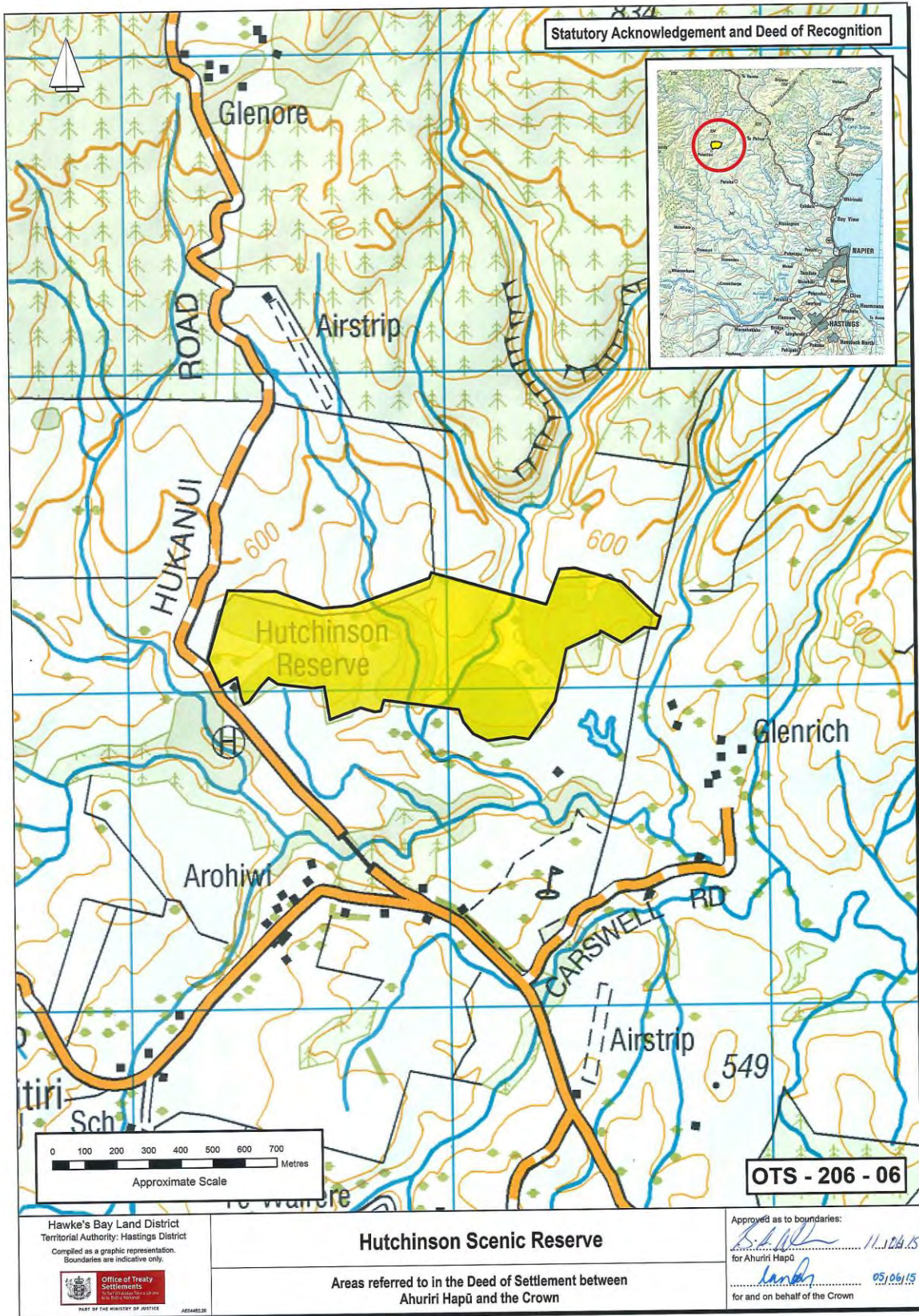

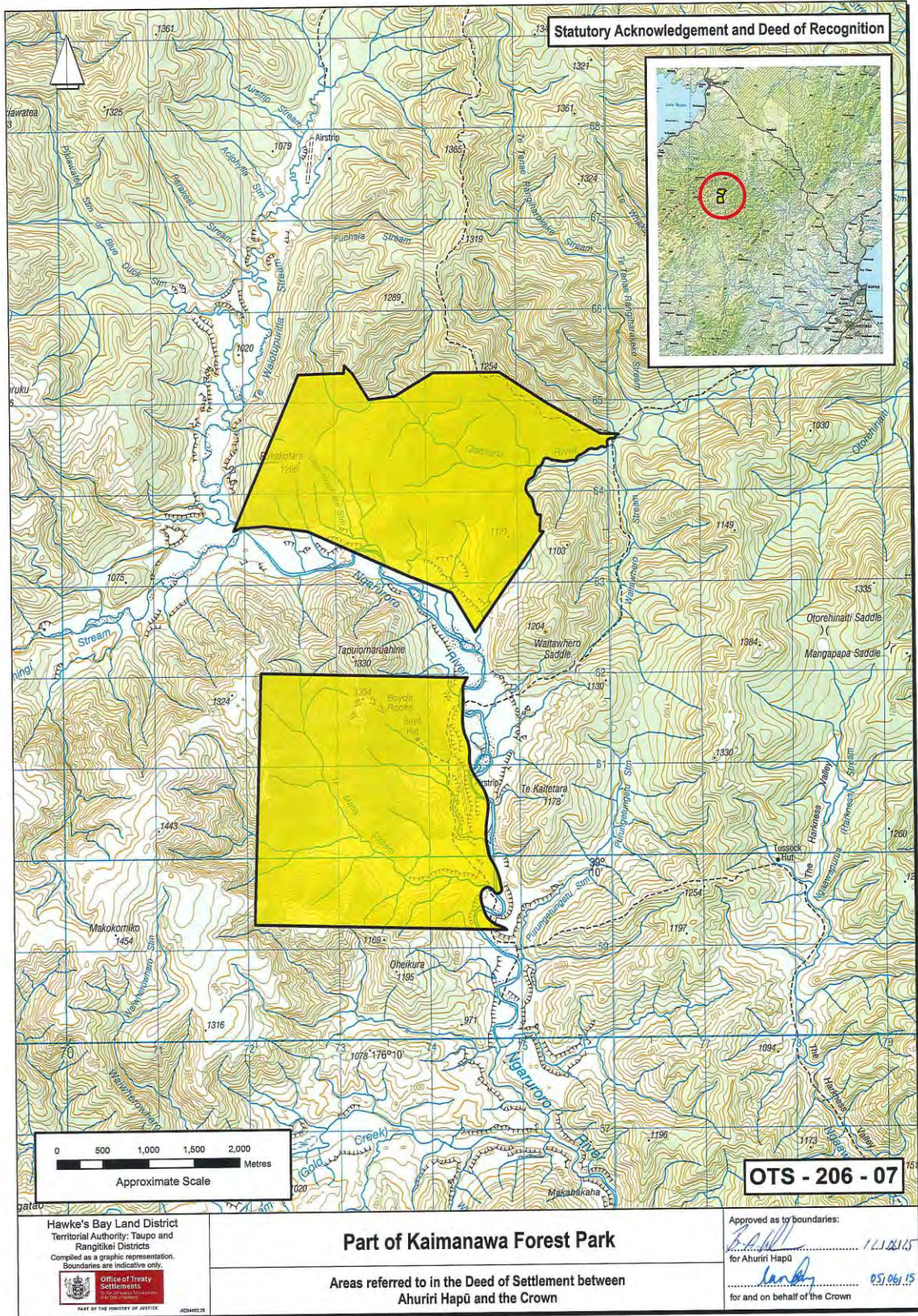

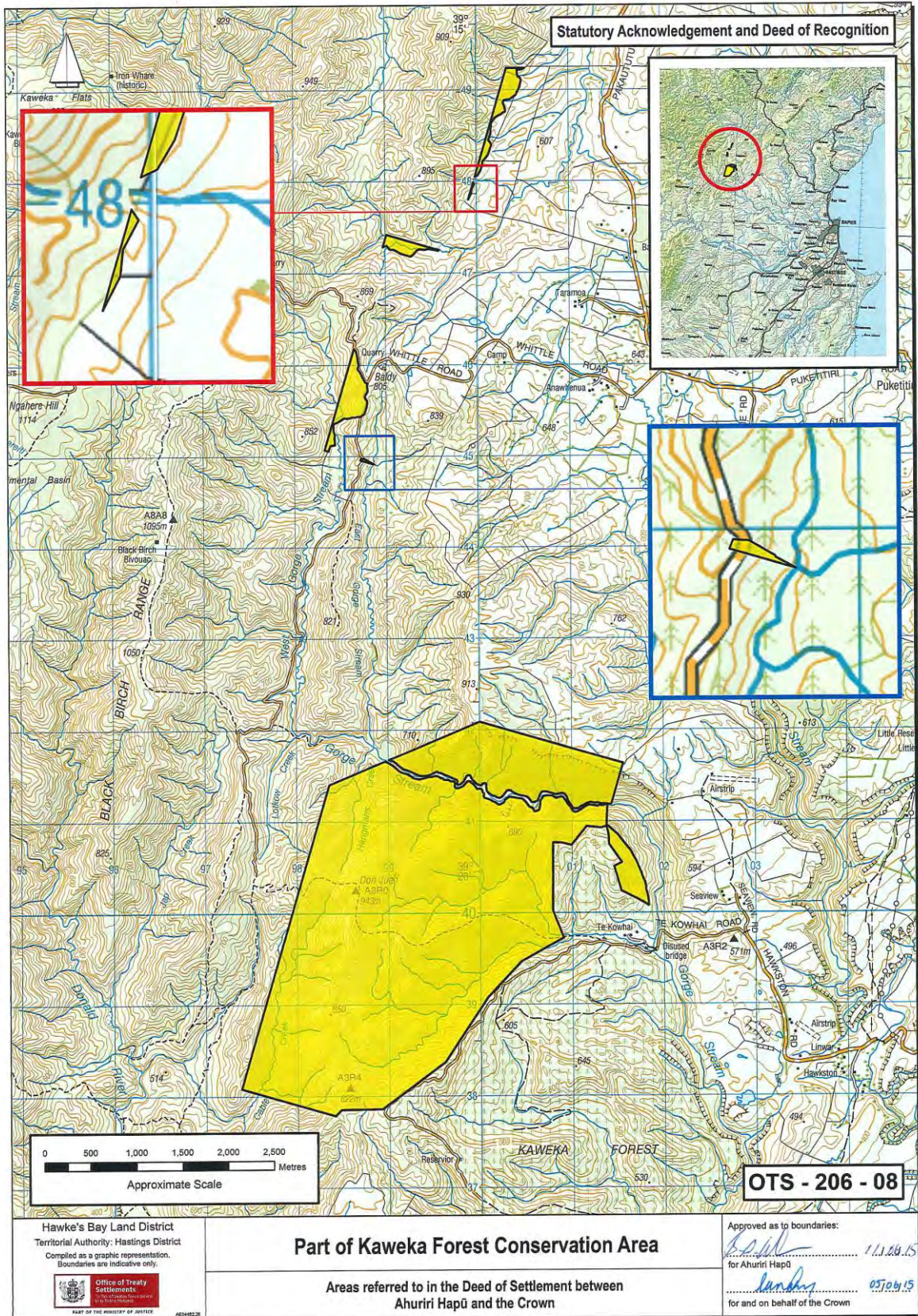
PART OF KAIMANAWA FOREST PARK

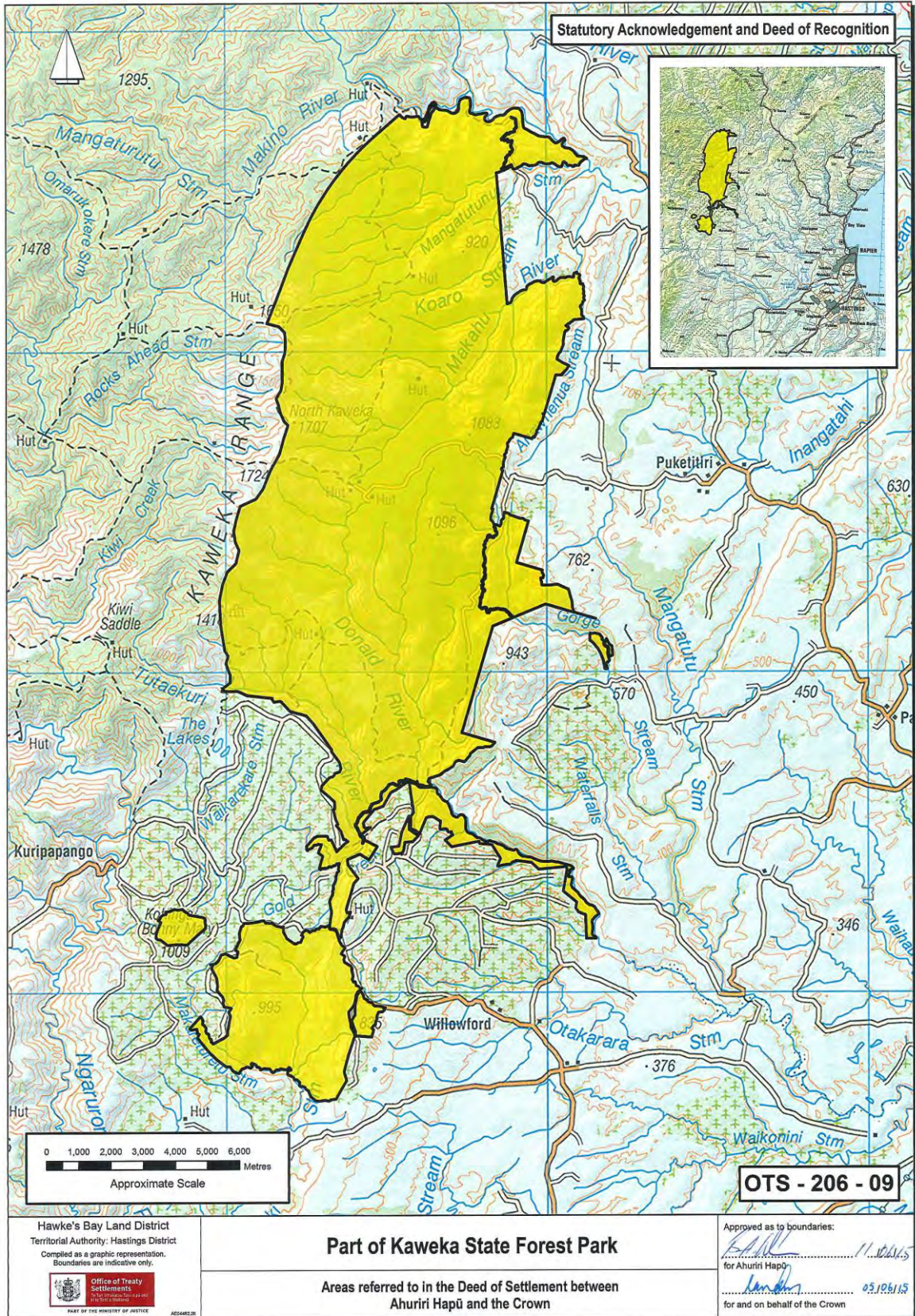

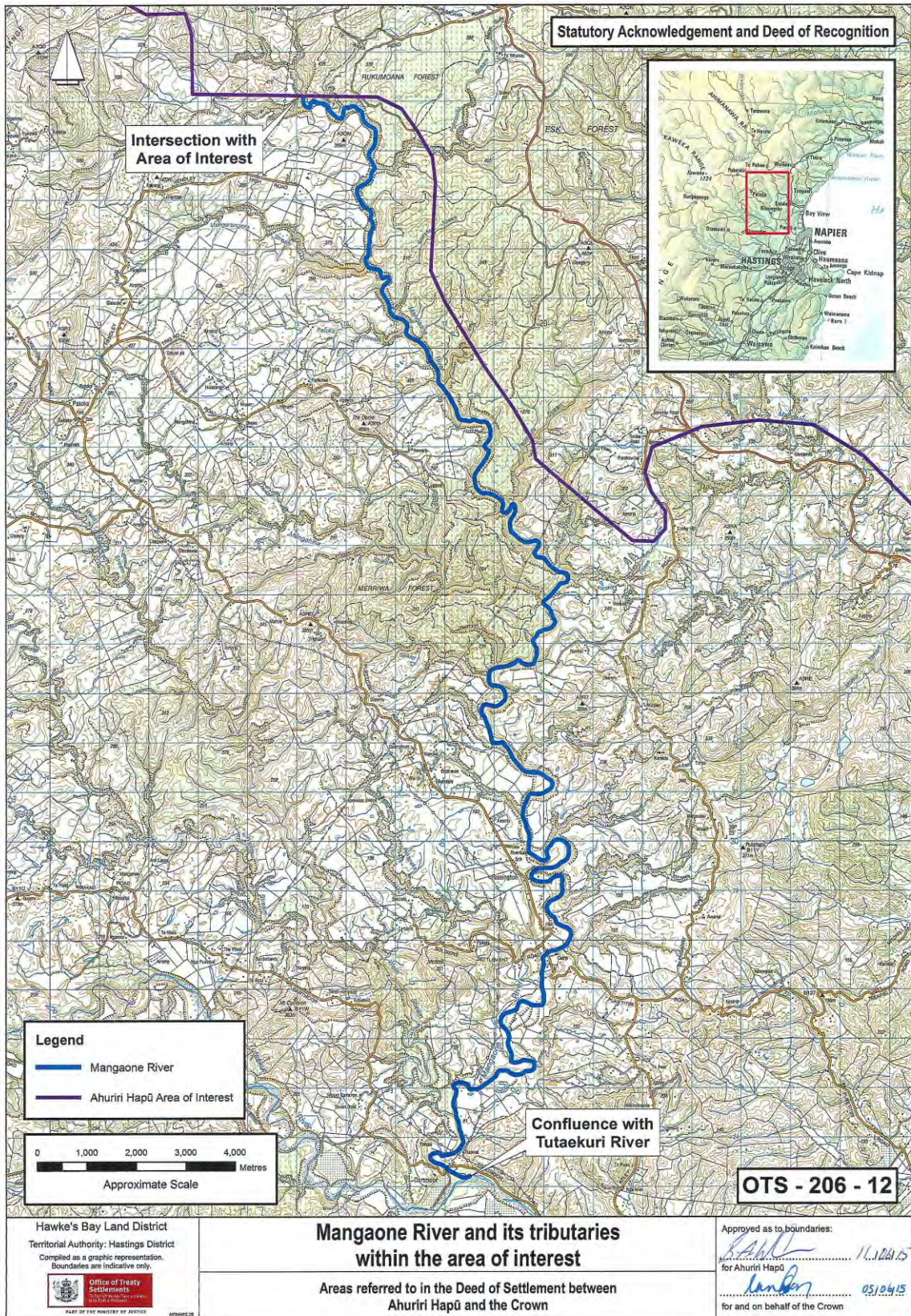

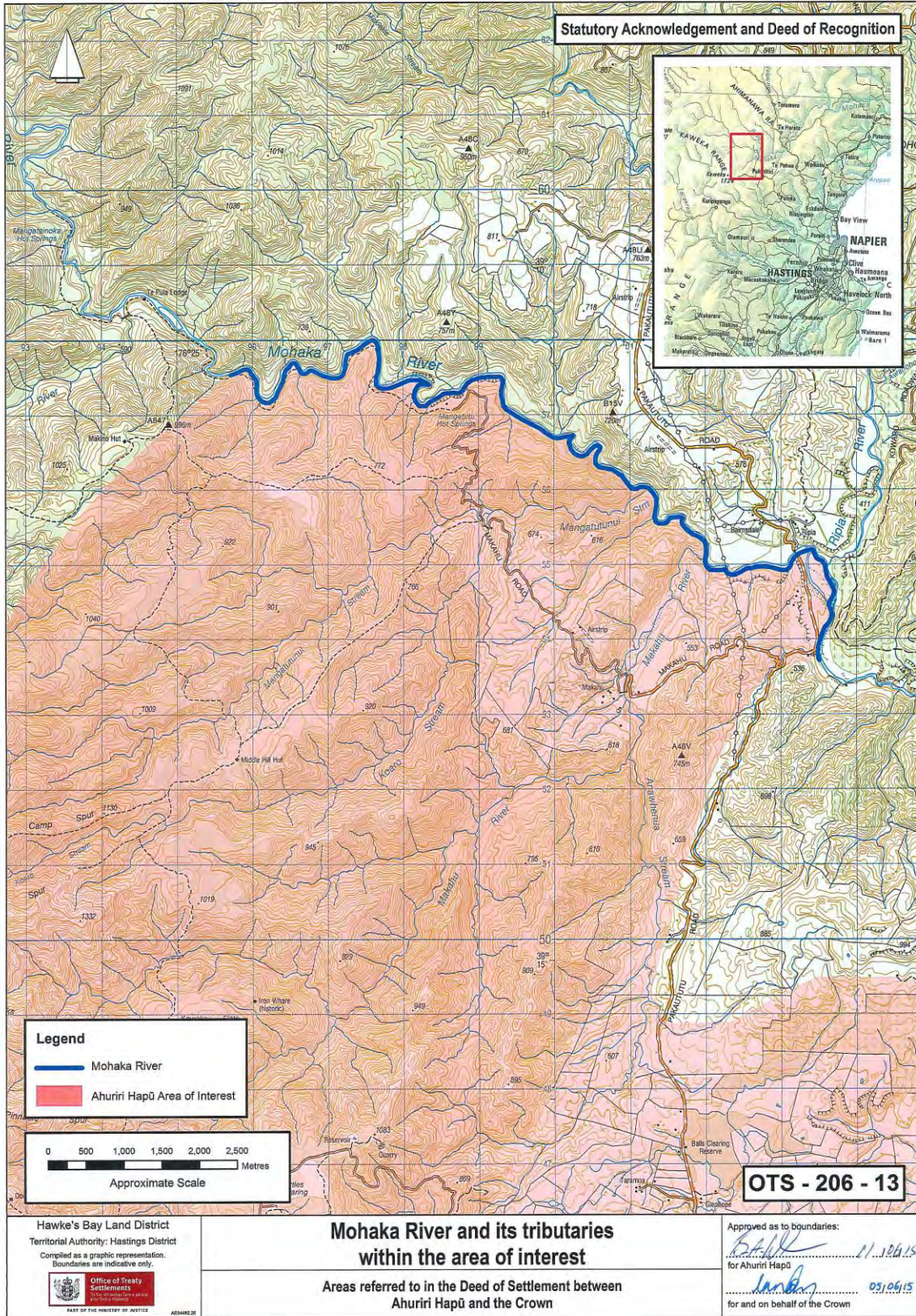
MANGAONE RIVER AND ITS TRIBUTARIES WITHIN THE AREA OF INTEREST

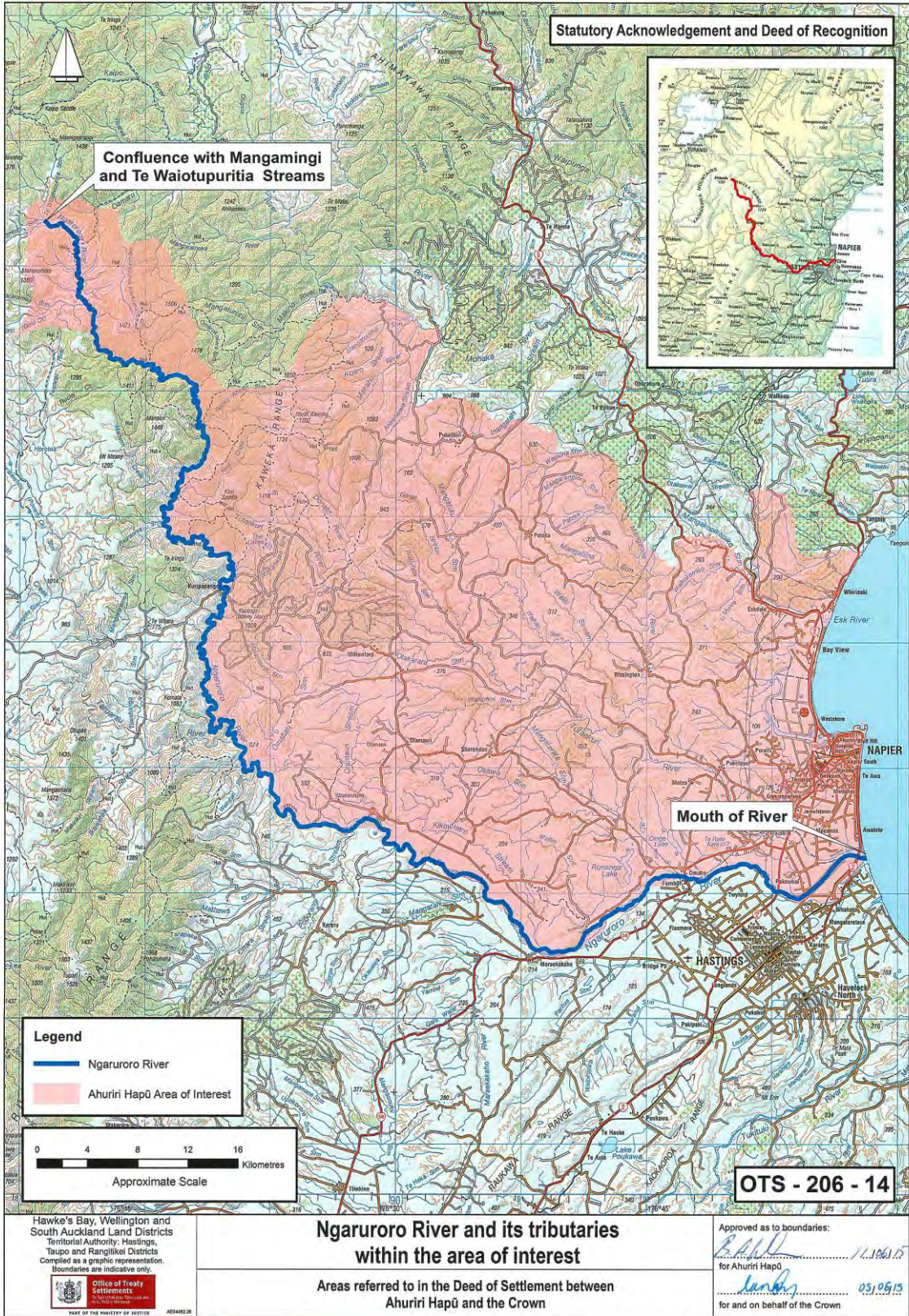

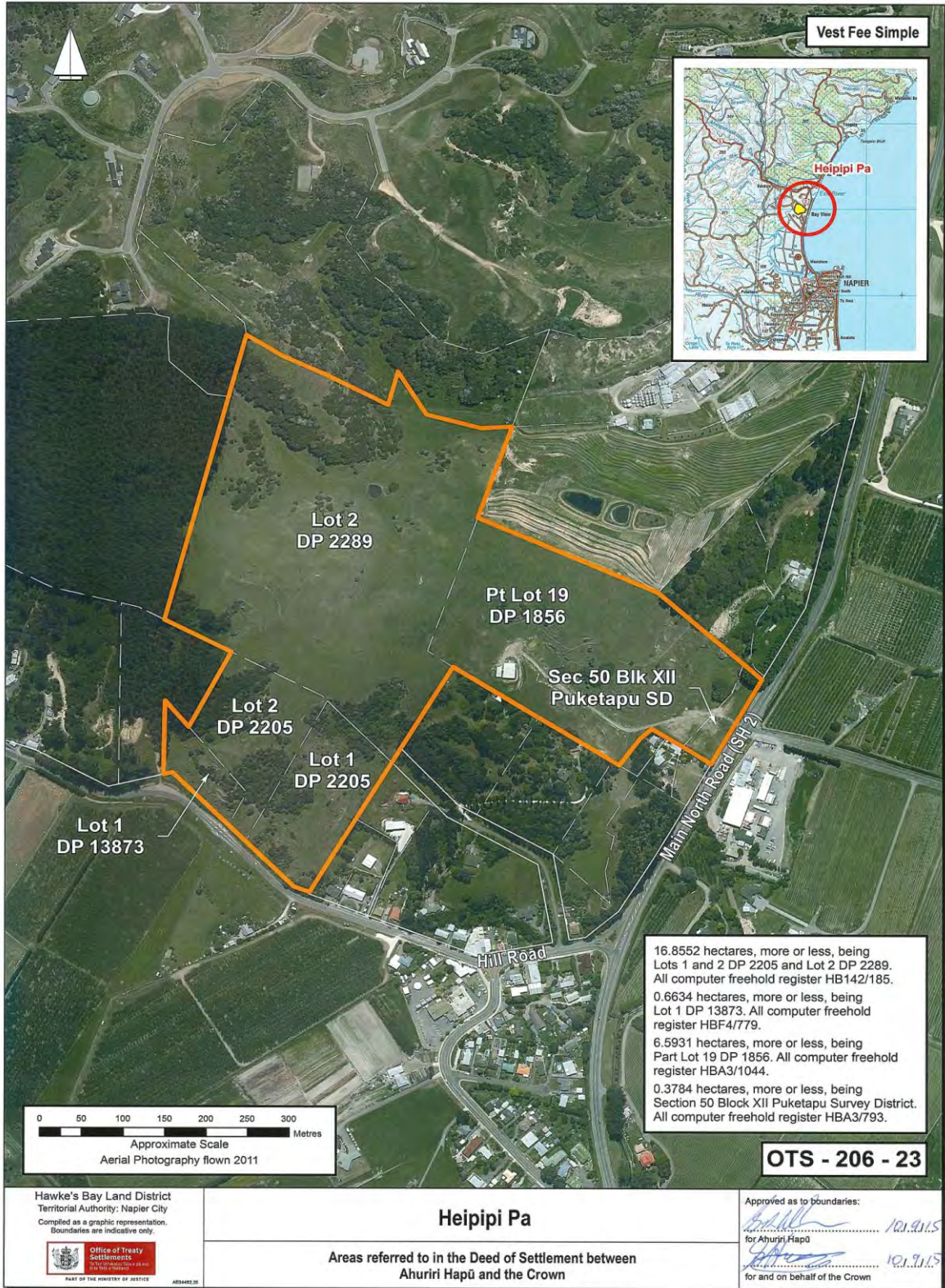
